

Permanent Permission for Unaided Secondary Schools

Subject: Granting permission to start new unaided secondary schools for the academic year 2005–2006.

Reference: Government Resolution No. SSN 2103/150/03/Mashi-2, dated 20 May 2003.

1. In accordance with the decision taken by the Government regarding granting permission to secondary schools,
2. the institutions listed in the annexure are hereby granted permission to start new unaided secondary schools at the specified locations and mediums from the academic year 2005–2006.

Permission is granted subject to the following conditions:

1. These secondary schools are permitted on a permanent unaided basis. They will not be eligible for any financial assistance or grants from the Government in the future.
2. The schools must strictly follow all orders issued by the Government from time to time, including the Maharashtra Employees of Private Schools (Conditions of Service) Regulation Act, 1981.
3. The institution must submit an affidavit confirming compliance with the conditions and procedures outlined in the Government Resolution dated 27 May 2003.
4. The financial condition of the institution must be satisfactory.
5. A signboard stating "Permanently Unaided School" must be prominently displayed at the school entrance for public awareness.
6. All correspondence with authorities must use letterhead stating "Permanently Unaided School."
7. The school must strictly follow Government orders regarding student admissions.

8. For English-medium schools, the institution must submit a written undertaking from the President stating that no future demand for grants or fee reimbursement will be made. This document must be securely preserved by the Deputy Director of Education.
3. Before granting final permission, the following must be verified:
1. The institution must be registered under the Mumbai Public Trusts Act, 1950 and/or the Societies Registration Act, 1860.
 2. There must be no ongoing litigation in any court regarding the proposal submitted by the institution.
 3. The school must be entered into the register of "Permanently Unaided Schools."
 4. Permission should only be granted after thorough verification of compliance with all conditions.
 5. Immediate action must be taken to complete the permission process and submit a report to the Government.
